PLEASE READ THIS! At least one current photo is required with this registration form. The photo needs to be an actual photo wherein the face should be about 1 x1 in size, or approximately passport size. Face shots within a photo are acceptable. Do not cut the face out of a photo - attach the entire photo. Photos will not be accepted if the person is wearing sunglasses or a hat. Xeroxed copied of pictures or photos are not accepted.

SECTION A: PLAYER INSTRUCTIONS – Please complete the information below and read the information on the back side of this form. Where appropriate, include the date and your signature. This form serves as a USSF “A” Form registration. This form must be completed in either black or blue ink and print firmly. Sections B & C must be completed before the Utah Soccer Association can issue a player pass.

NOTE: PARENTAL PERMISSION IS REQUIRED IF A PLAYER IS UNDER THE AGE OF 18. SEE SECTION E ON THE BACK SIDE. IN ORDER TO BE ELIGIBLE TO PLAY IN THE UTAH SOCCER ASSOCIATION, PLAYERS WHO ARE CURRENTLY OR ARE GOING TO BE REGISTERED ON A YOUTH TEAM MUST COMPLETE A “SPECIALTY PLAYER ACTION FORM” WHICH CAN BE OBTAINED FROM THE UTAH YOUTH SOCCER ASSOCIATION.

SECTION D: AMATEUR ATHLETIC WAIVER AND RELEASE OF LIABILITY (ASSUMPTION AND ACKNOWLEDGEMENT OF RISKS AND RELEASE OF LIABILITY AGREEMENT)

In consideration for being allowed to participate in any way in the UTAH SOCCER ASSOCIATION, INC., USASA, USSF, its Affiliates, Associates, Leagues and Member Clubs/Teams, its related events and activities, the afore signed acknowledges, appreciates and agrees that:

1. The risk of injury from activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of injury does exist, and
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation, and
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will bring such to the attention of the nearest official immediately, and
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS THE UNITED STATES SOCCER FEDERATION, UNITED STATES ADULT SOCCER ASSOCIATION, UTAH SOCCER ASSOCIATION, its affiliates, associates, leagues and member clubs/teams, their officers, agents and/or employees, other sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH or loss or damage to person or property, WHETHER ARISING FROM NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
5. Soccer is a contact sport involving risk of serious injury, disability, or death. Not all risks are foreseeable. In consideration of being allowed to participate, I agree to release, waive, and covenant not to sue the United States Soccer Federation, United States Adult Soccer Association, Utah Soccer Association or their affiliates on account of injury, death or property damage alleged to be caused in whole or part by affiliates' actions or omissions. 6. ***This registration application is valid for the period starting from your registration date until the end of 2014. It is understood that once you have paid the registration fee, this registration is non-transferable and refunds or partial refunds are not given. Your registration fee pays for the player pass which entitles you to play for a designated team until the end of the 2014 season, whether you play in all, one or no games.***

SECTION F: INTERNATIONAL CLEARANCE

THE TEAM FOR WHICH YOU ARE REGISTERED IS AFFILIATED WITH THE UTAH SOCCER ASSOCIATION. YOU MUST BE REGISTERED ON THIS FORM AND THE TEAM MUST HAVE RECEIVED YOUR PLAYER PASS PRIOR TO YOUR BEING ELIGIBLE TO PLAY IN ANY GAME WITHIN THIS ASSOCIATION. PLAYING WITHOUT A LEGAL PLAYER PASS WILL RESULT IN SANCTIONS AGAINST THE TEAM AND/OR PLAYER. Please read all of the instructions and contents of this form carefully, since accurate completion is necessary for proper validation of your liability insurance.
